The recovery for the Surrogate Standard in this sample was below its acceptance range. The breakdown for Endrin in the Breakdown Standard was 23%. The recovery for Chlordane in the LCS Standard was above its acceptance range. Recoveries for 7 of the 9 compounds in the Spiked Sample were below their acceptance ranges.
