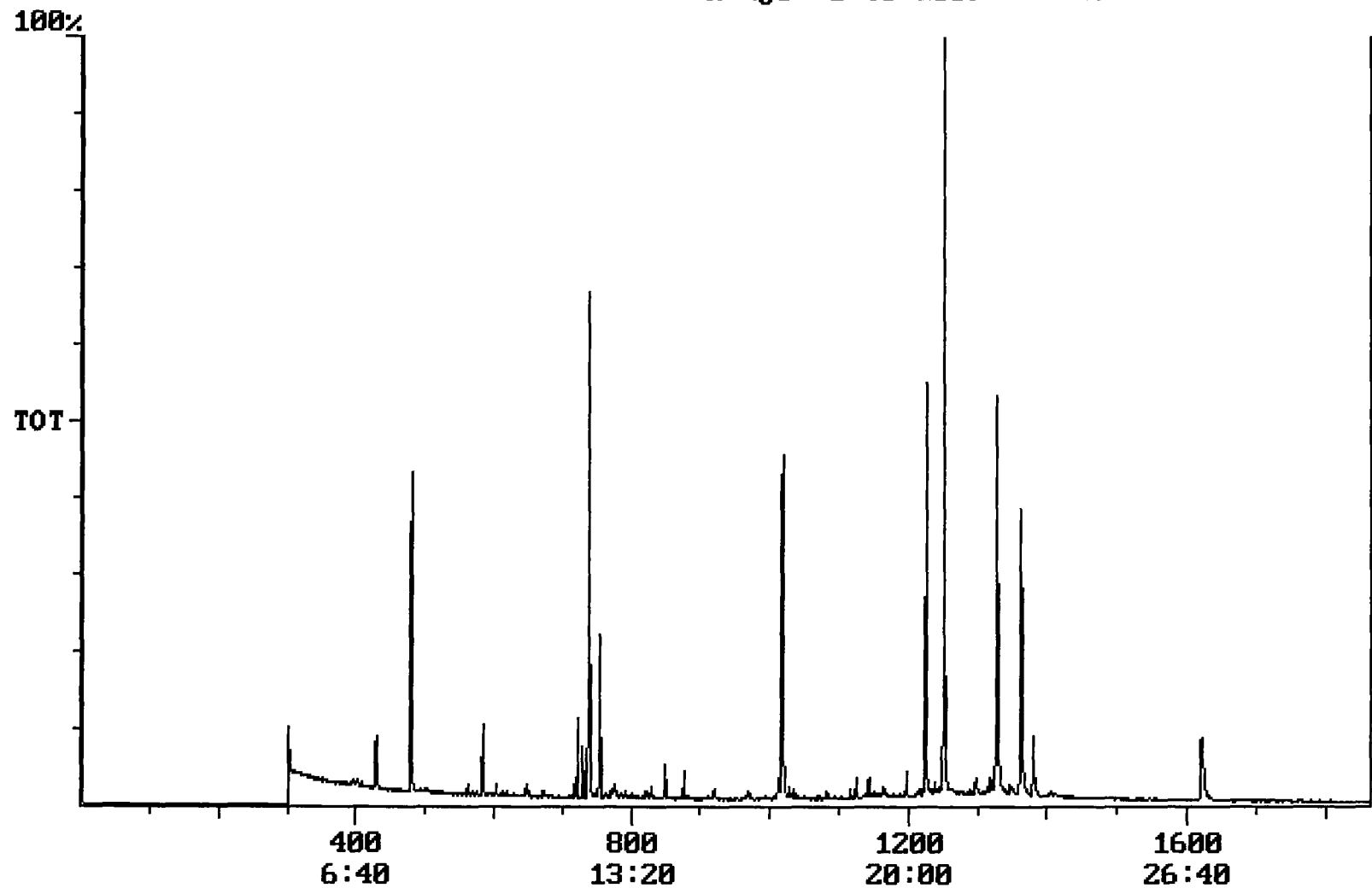

Recoveries for 3 of the 18 compounds in the MDL and LCS Standards were outside of their acceptance ranges. Recoveries for 6 of the 18 compounds in the Spiked Sample were outside of their acceptance ranges. The breakdown for Endrin in the LPC Standard was 53%. The level for bis(2-Ethylhexyl)phthalate in the Laboratory Blank was 0.74 ug/L.
