The new Manhattan Executive Office in Room 1019 at the Municipal Building is ready for our use.

There are two combination locks which are required to enter room 1019 - to enter the DCAS area from the hallway you must press "3,1,5". To enter DEP's secured area you must press "3,5,4,2".

In regards to telephones, 212-669-4022 is the number in the Commissioner's Office (with a rollover to 669-5174) and 212-669-4020 is on the desk in the outer area. In order to make long distance calls, you will need to dial *6418357 + 9 + number.

Also, please note that the codes to enter the restrooms are as follows: men's - 5,3,1; women's - 4,1,3.
