I called her back - Told her that DEP did a survey of 452 bldgs. in the downtown area + identified bldgs. (211) with debris - letters were sent to owners who were advised to do an assessment + proper clean-up.

For St. Paul's, DEP identified visible ~~debris~~ debris in the courtyard + cemetery; letter sent accompanied by DEP Guidelines for hiring a DEP/NYSDOL certified investigator to do an assessment of the bldg. grounds + common areas. No time frame for assessment or, clean-up if necessary, was given. Had a time frame been given it wld. have been in the form of a "Commissioner's Order," which was not given in this case. [An assessment is done first then appropriate clean-up afterwards]
