The primary objective of the meeting is to indicate the City's commitment to making Lower Manhattan a world-class business district. The Mayor, yourself, and other City agency heads will be presenting Lower Manhattan status updates to 14 CEOs of large downtown firms.

We are hoping to get a draft together by the end of the day tomorrow, sorry for the short notice, and thank you very much.
