Dear Mr. Heavey:

This is in response to your recent applications for payment. Specifically, this addresses WTC-ARD Payment Applications 22, 23, and 24.

The New York City Department of Environmental Protection has reviewed the information and has determined that in accordance with the scope of work for the project the cleaning contractor was responsible for cleaning residences, common spaces and portions of HVAC systems. Please refer to page 2 of WTC-ARD that states:

The Cleaning Contractor is responsible for cleaning residences, common spaces, and portions of HVAC systems identified by the Monitoring Contractor.

The cleaning of baseboard heaters in common spaces is not a separate billable item and is not reimbursable under the terms of the contract. In addition, the cleaning of "through the wall HVAC units" is not a separate or additional item and is not reimbursable under the terms of the contract.
