PLM analytical result for samples from complainant's apartment. Result indicates the sample was not asbestos containing material (ACM). Handwritten notes indicate reanalysis with TEM found chrysotile present. The sample was analyzed on 10/9/01. TEM bulk sample results from SciLab indicated chrysotile was present but sample was insufficient to quantify (12/4/01).
PLM bulk sampling report for North Atlantic Laboratories indicated four (4) samples collected from complainant's apartment were not ACM. Handwritten comments and circled fibrous glass results. Samples were analyzed 12/4/01.
November 1, 2001 notice from Liberty Court indicating scheduled cleaning of exhaust vents in all B Line Apartments.
TEM result for sample collected from complainant's apartment indicated sample was not ACM. Sample was analyzed on 12/16/01. Chrysotile <1.0 was circled.
Forward of e-mail regarding health effects from fibrous glass.
PLM bulk sample results for apartment 17J, includes handwritten notes. Samples were analyzed on 2/18/02 and were found to not be ACM.
Printout of e-mails regarding environmental sampling and health effects.

[PII] wore a dust mask during inspection. She stated four carcinogens were in the air, one of which was asbestos. However, based on testing of her apartment for asbestos, none was found. Inspection of her apartment revealed that there was no visible WTC debris. The apartment was reported as "extremely untidy with clothes, paper, and boxes scattered everywhere". Pieces of floorboards were missing. She was dissatisfied with the policies of various agencies. She addressed issues regarding fiberglass as a carcinogen and the need for it to be cleaned up. Based on site observations and complainant's sample results, no further action taken.

3/06/2002 [PII] - Inspection revealed that there was no visible WTC debris in the apartment. [PII] wanted to have the air in the apartment tested. She was faxed a copy of various air monitoring contractors.
