Respondents are asked to accept this notice of claim on behalf of all those who have suffered damages as result of the April 30, 2014 Flood, both known and unknown (John Does and Jane Does) at this time, as there is no prejudice to respondent for doing same.

2. The nature of the claim:

Claim for personal injuries, property damage, loss of property, cost of cleaning; cost of repairs, lost wages, loss of property values, and a compromised ability to obtain insurance, which may result in future damages, *inter alia*, arising out of an incident involving the of flooding of claimants' homes, premises, and property, both real and personal, which occurred on April 30, 2014, in the neighborhood known as Lindenwood, Howard Beach, County of Queens, City of New York, State of New York, zip code 11414, due to the negligence of the respondents herein.

3. The time when, the place where, and the manner in which the claim arose:

The incident occurred on April 30, 2014, in the neighborhood known as Howard Beach, County of Queens, City of New York, zip code 11414, after significant rainfall that day, when, sometime in the late afternoon or evening, and continuing for hours into the early hours of the following morning, the claimants were caused to suffer catastrophic property losses resulting from a flood. Said flood was caused by a defect and/or failure in the drainage and/or sewer system and/or sanitary and storm combined sewer system located at and/or throughout said neighborhood, or, the drainage and or sewer system and/or facility that is responsible for maintaining water, sewage, and drainage in the subject neighborhood. Respondents engaged in an act that caused the incident, or the respondents failed to engage in an act, and such failure caused the incident. Respondents failed to properly man a facility; respondents failed to properly clean and/or maintain the subject sewers and/or drainage system in the neighborhood; respondents failed to properly control relevant valves, and/or gates, and/or dams, and/or other properties or materials pertaining to a sewage and/or drainage system; and were otherwise negligent.

Because of the negligence of respondents, claimants were caused to endure large amounts of water within their homes and/or garages, ranging from several inches to several feet, destroying and damaging massive amounts of property, and causing massive amounts of damage to the homes themselves, requiring repair, demolition, replacement, cleaning and mold removal, among other things. Further, the property values of respondents' homes are believed to have decreased dramatically due to this flood resulting from the negligence of the respondents.

Respondents created, caused, and allowed a dangerous and hazardous condition to exist and persist. That the negligence of respondents consisted of failing to properly and safely maintain and control the aforementioned sewer and/or drainage system; in allowing the existence of a condition which was known or should have been known to cause damage or destruction of property, or be inherently dangerous and/or hazardous; in allowing a condition to exist that posed a risk to the citizens and residents of the aforementioned neighborhood; in allowing the sewer and/or draining system to remain in a defective state and/or condition; in causing and permitting a dangerous condition; in failing to act in a reasonable and prudent manner; in creating a condition which caused claimants to be damaged; in negligently maintaining and/or repairing said sewer and/or drainage system, or in failing to entirely; in negligently inspecting said sewer and/or drainage system, or in failing to entirely; in failing to give any warning of the impending flood; in failing to properly prevent the subject flood.

Said incident was the result of the negligence and carelessness of the respondents herein, their agents, servants, and/or employees, in disregarding their duty to maintain the sewer and/or drainage system in a safe and proper manner; in failing to act as reasonable and prudent persons would have acted under the circumstances then and there existing; in failing to properly maintain and/or repair the above-identified location and surrounding areas in a safe and proper condition; in failing to properly inspect the above-identified location; in permitting said area and surrounding areas to become dangerous and defective as described above, thus creating a dangerous and hazardous condition that caused significant losses; in undertaking to act and in so acting, failed to act in a reasonable and prudent manner; in creating a condition which caused claimants to lose significant amounts of personal property and suffer significant amounts of damage to real and structural property; in

causing the existence of mold in claimant's homes and residences; in exposing claimants to harmful pathogens, bacteria, and other hazardous and unknown substances; in failing to give any warning of the hazardous condition. Said conduct, by permitting and allowing the above-identified dangerous condition to exist, thereby creating a hazardous and dangerous condition, and failing to repair, maintain, and control, shows a complete disregard for the safety and well-being of claimants.

Respondents had at least constructive notice of said condition but permitted same to remain uncorrected. Respondents had actual notice of said condition but permitted same to remain uncorrected. Respondents had prior written notice of said condition. Respondents caused and created the condition. Respondents knew the weather report called for significant rainfall, but failed to take any action at any reasonable time prior to the flood to prevent flooding, failed to man relevant and crucial facilities; failed to implement any type of fail-safe procedure at relevant and crucial facilities, although duly had ample opportunity to do so, thus creating the defective and hazardous condition.

That the negligence of respondents consisted of failing to properly and safely maintain and control the aforementioned area; in neglecting and/or failing to properly maintain, inspect, and/or repair the infrastructure of the aforementioned sewer and/or drainage system in the aforementioned neighborhood, and thereby causing the resulting flood and creating the condition complained of; in failing to properly clear and/or clean sewers in a reasonable, and/or regular, and/or timely manner in the aforementioned neighborhood of debris; in failing to prevent a backup of water during a rainstorm; in failing to properly man related facilities, including but not limited to the Spring Creek [Combined Sewer Overflow] Facility; in failing to properly maintain, control, manage, and/or repair that and/or other facilities, including but not limited to the Spring Creek [Combined Sewer Overflow] Facility; in allowing improperly and incorrectly pitched catch basins to remain in a defective, inadequate, and ineffective condition; in allowing and permitting a failure to occur at a related sewer overflow facility, causing sewers to back up into claimants' homes; in failing to properly and timely upgrade and/or maintain the subject sewer system; in failing to properly clean sewer grates and/or allowing garbage and debris to accumulate in same; in negligently relying on computer action rather than human action; in causing and permitting a dangerous condition; in failing to act in

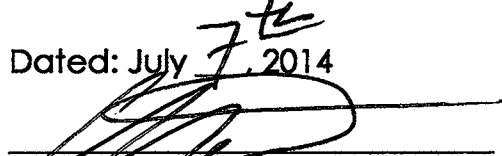
a reasonable and prudent manner; in creating a hazardous condition; in failing to comply with the appropriate code requirements; in and thereby creating a hazardous and dangerous condition.

4. The items of damage or injuries claimed are:

All claimants suffered serious, significant, and substantial damage to and losses of substantial amounts of personal property; claimants suffered serious, significant, and substantial damage to real and/or structural property, requiring replacement and/or demolition and/or extensive repairs, as well as cleaning and mold removal. Claimants have suffered property value losses. Claimants have suffered lost time from work and lost wages. Claimants have suffered personal injuries as a result of mold; claimants have also experienced exposure to pathogens, bacteria, and other unknown substances due to exposure to unsanitary sewer water which will or may lead to illness. Claimant's ability to obtain renters and/or home owners' insurance has been compromised, which will or may result in additional future damages. The full extent of all damages is currently unknown.

The undersigned therefore signs and presents this claim for adjustment and payment on behalf of all claimants pursuant to General Municipal Law Section 50-e(2). You are hereby notified that unless it is adjusted and paid, the claimants intend to commence an action on this claim.
