 - 2- issues we know the Assembly is interested in (e.g. ULSD, FEMA funding requests)
 - 3- (if applicable) the status of any commitments your agency made at the November hearing
 - 4- what message do we want to get out (overall strategy, agencies working together, etc.)
- State Leg. will let us know if they get more info.

Thanks, and please let me know who from your agency will be there tomorrow.
