PROPOSALS INCLUDING INSTALLATION: Field painting is not included. Wire, wiring, or setting of limit switches is not included. Dismantling and/or removal of existing doors is not included.

SPECIFICATION: Products are to be furnished in accordance with standard specifications as shown in current literature.

MATERIALS: All exposed ferrous surfaces, other than galvanized surfaces, shall receive one shop coat of rust-inhibitive metal primer. Wire, conduit, fuses and disconnect switches are not included. Wiring diagrams will be furnished.

TIME LIMIT: This Proposal shall be deemed withdrawn within 45 days from date, and is, in the meantime, subject to change upon notice.

PREPARATION OF OPENINGS: Jambos, lintels, sills or other structural elements required to prepare openings are not included. Flat vertical walls, of sound and suitable construction, with required clearances, are to be provided by others. Encumbrances obstructing required clearances are to be removed by the purchaser.

In the construction of new openings, the purchaser will be responsible for the maintenance of certified dimensions on approved shop drawings, or of dimensions as guaranteed otherwise.

GUARANTEE: Doors shall be guaranteed against defective materials and workmanship for a period of one year from date of shipment, and installation shall be so guaranteed when performed.
